Scientists and ecological protesters have been warning of the possible effects of climate change for some time. The increase in the production of carbon dioxide from over use of the car, from fossil fuel energy sources, and other man-made contaminants of our atmosphere are set to change irreversibly the climate we are used to. And while many people think that global warming will mean Manchester will become more like Barcelona, in reality it may well mean more rain and freak weather conditions like those we are witnessing now.

Politicians and multinational companies (some of the main culprits in our changing ecosystems) have been paying lip service to green issues and issues about global warming, but have done very little to combat it, choosing to ignore the warnings.

When you consider that climate change is caused by over-consumption of fossil fuels by the rich, often with their extraction

# **GM on Trial**

The trial starts on the 13<sup>th</sup> Nov of 5 anti-GM activists from Manchester. They are being tried for £200 damage to genetically modified oil seed rape in Oct 99 - an accountable action taken in daylight. The test site was completely destroyed and the plants handed to the police who asked if they could smoke them!?

For the first time in a GM trial the defence will be allowed expert witnesses. Also appearing at the trial will be a representative from Agrevo, now known as Advanta, and arresting officer P. C.

So what can we do?

From November 11-24 the sixth round of United Nations climate negotiations will take place in the Hague; during this round the focus will be on ways industrialised countries can achieve the reduction targets they committed themselves to in the Kyoto Protocol. Activists ask, are the solutions more selfish than selfiess?

Rising Tide protests in the Hague Rising Tide is a network of grass roots resistance to the hot air of the politicians on climate change. An alternative summit, festival and direct action protests are planned for the Hague, A sizeable number of activists will be travelling from this country to join in, and there will be a day of discussion and training beforehand. Meanwhile the Government is hell-bent on growing more GM crops. We already have the controversial farm scale trials and now they are set to give the first commercial licence to a GM seed - a maize intended to be fed to cattle. Before a seed can be sold to farmers it must be on the National Seed List. The Government has proposed that a GM maize produced by Aventis should go on the list. However, Friends of the Earth has discovered seldom-used laws that

being at the expense of the poor, that the first people to feel the effect of climate change are the poor, because only the rich can pay for expensive adaptive measures, that the process designed to prevent climate change involves solutions designed the rich which involve displacing the poor but

making money for the rich; then you stop seeing climate change as a problem of atmosphere and gases and one of class war.

#### **Local Actions**

Although it's important to travel to places like Prague and the Hague to add our voices to those of activists from around the world, local action is crucial.

Local residents and others from Manchester did their bit at the end of last month when they disrupted the opening of the M60. Previously known as the M66, this road, dubbed "Manchester's Ring of Concrete" was the subject a couple of years ago of a big campaign by local people and road protesters. The road not only runs through people's towns destroying communities, but has also decimated some of the last remaining wildlife sites and green areas in East Manchester. Around twenty people delayed the official opening by an hour, by trying to have a picnic on the road, before being chased off by police.



# Animal Rights and Sabbing

The official hunting season is now open, after 2 months of "autumn hunting" (a PR term meaning "cubbing"). Manchester, Bolton an Lancaster sabs have been concentrating on Cheshire Forest foxhounds who haven't slaughtered many furry animals yet due to the countryside being waterlogged lots.

Recently and effective day's sabbing meant the hunt failed to kill any of the six foxes/cubs they were hunting, so they have been calling on the Cheshire constabulary. Seeing pie-stuffed policeman trying to run across fields is always a sight to behold! New sabs are always very welcome. Ring 0961 113084 to get involved.

Attention continues to be focused on Huntingdon Life Sciences. The four volunteers from Stop Huntingdon Animal Cruelty arrested on 15<sup>th</sup> August have been released on strict bail conditions. They have been charged with conspiracy to incite mental GBH (!) of workers, conspiracy to incite criminal damage and conspiracy to incite harassment - all in one newsletter apparently.

A few days later animal loving campaigners met police blockades outside HLS, so they held a

demonstration outside the home of HLS supporter and former prime minister John Major. The hapless decent bloke was seen running across his lawn apparently in some state of panic, as 25 armed police stood guard and a helicopter buzzed overhead.

The campaigns against HLS and Newchurch Guinea Pig farm (breeders for the vivisection industry) continue to go from strength to strength, and with regular input from NW activists.

Transport goes to the regional HLS demos every other Thursday and is free/donation if you're unemployed. Activists against Newchurch visit every night of the week. For NW/Mcr people it's Tuesday. The continued pressure has led to the Hall's selling off land to pay for security and it can't be long before they decide selling guinea pigs to be tortured is more trouble than it's worth.

## Silent March

The Federation of Deaf People organised the second national march in London for the recognition of British Sign Language (BSL) as an official language. Manchester sent two coachloads of people to help make un the more than 9,000 people who attended. BSL is the fourth most commonly used language in this country (after English, Welsh and Gaelic) but remains unrecognised by the government. Other European governments have already given their own national sign language an official status. Deaf people continue to face discrimination in education, employment and participation in community life despite the recent passing into law of the Disability Discrimination Act, which contains many loop-holes.

# Nine Ladies Anti-Quarry Campaign 1st Anniversary bash

An intrepid Manchester activist visited the anti-quarry protest site .....

"Two hours out of Manchester and a 2 mile trek up on a steep hill is the beautiful Nine Ladies stone circle and its woods and pastures. Abandoning my self reliance, I stuck my thumb out, and a police landrover stopped. After some harassment I was allowed to join the 60-odd smiley dirty faces round a huge fire in a barn covered by tarpaulin. The morning after I saw the toilets, treehouses, kitchens and ropes that the 15 or so current residents had used to host us safely. I spoke to a veteran, although concerned with public safety and his privacy he was welcoming ramblers to look around and sign a petition.

Later on Sunday as we were out picking mushrooms, I heard a trumpeter. A small group had occupied the working quarry next door. Now a helicopter wsa flying and cops in two riot vans had managed to nick somone for sitting on a stone wall (it collapsed). We celebrated with mushroom soup and fine juggling. The next day a jail solidarity posse

gathered in a small Derbyshire town as I made my way back to the City with a soaked sleeping bag and fond memories."

In a recent email Jon Humble, Inspector of Ancient Monuments for English Heritage, wrote "In July an encouraging meeting was held with the landowners, the mineral companies, Peak Park planners and ourselves we hope that it may well be possible to identify a solution based on the

companies relinquishing their commercial interests in Stanton Moor. The companies will expect, however, to obtain planning permission for stone extraction elsewhere as a trade-off... if this does prove possible it would be on condition that "elsewhere" is a less environmentally sensitive area!"



# World Bankers Flee Prague PRAH

The annual meeting of the World Bank and International Monetary Fund ended early and in confusion after approximately 15,000 anti-globalisation protesters threw another spanner in the works and brought the meeting to a standstill. The protest included a sizeable Manchester contingent which linked with other UK and international activists to form the pink and silver parade, complete with a samba band and dance troupe decorated in tinfoil and pink balloons.

Despite the presence of a paramilitary police force that made liberal use of percussion grenades, tear gas and water cannons, conference delegates lost confidence in the security arrangements and abandoned the proceedings. On the 27th September the South African finance minister, Trevor Manuel, told a nearly empty hall that "official business had been dealt

## AntiFa take the streets

On the 23<sup>rd</sup> September just short of a thousands joined a banned antifascist mobilisation in response to an authorised European wide fascist rally and mach against the IMF and the World Bank. The antifascist march, largely made up of anarchists and organised into affinity groups, made for a powerful presence. Leaving Namesti Miru it made its way peacefully and uncompromisingly through the centre of Prague, finally winding down in Wencelaus Square. Media reptiles scurrying around McDonalds in anticipation of flashpoint incidents were twice left disappointed. The fascist rally went ahead, numbering 60 in total and under heavy police guard.

mache puppets, multi-lingual banners, bands, dancers, sound systems, fancy dress, jugglers, and some placard carrying day trippers. The party went on all day and into the night. 11,000 police waited alongside army units surrounding the conference centre. Six tanks were parked up on an approaching bridge. The main body of the demonstration left to head for the north side of the conference centre and split into three groups for something of a set piece confrontation. A smaller group headed directly for the south side. Eventually protestors encountered and attempted to breach police lines. Chaotic and violent scenes soon broke out.

By late afternoon a number of activists had outwitted the police and gained entry to the hotel adjoining the conference centre and, as it turned out, blocked off the main exit for delegates. CEO's and directors had to make for the unfamiliar terrain of the underground metro.

The evening's cultural events were also disrupted. The prestigious opera was abandoned and a banquet laid on for the worlds leading bankers, economists and financiers besieged. Riots erupted in and around Wenceslaus Square later in the

#### **Tear Gas and Water Cannons**

The fiercest battles raged across a valley to the north side of the conference centre. The 'blue section' of the march largely consisted of black bloc anarchist groups, led at the front by Czech affinity groups. As part of the blue group Seattle's Infernal Noise Brigade used their instruments to force their way through a police cordon amidst a cloud of tear gas. On a nearby bridge Ya Basta!, padded out in white overalls and inflated inner tubes, took on the impossible iob of clearing police, water cannons and tanks from the bridge.

## Czech Police Respond with Torture and Abuse

This largely unreported victory was gained at a high price. In the days that followed police rounded up nearly 1000 activists, two-thirds of them Czech. Many were severely beaten, tied, sexually abused, gassed, denied food, sleep and water and otherwise tortured and humiliated whilst in police custody - reports confirmed by 2 activists from Manchester who were imprisoned. Many came out of prison nursing broken arms and fingers. One woman, according to police reports, "fell naked from a second-story window while trying to escape interrogation", suffering serious injuries. An Israeli activist was forced to share a cell with fascists for 3 days and left custody with a broken arm and badly bruised rib cage. There are similar accounts of abuse. In the light of these events and with the World Bank and IMF gone, demonstrations continued over the following days in Prague and many other cities including London in support of those held in prison. Pressure upon the Czech authorites has paid off with many now released. The latest update from OPH, the legal observers group in Prague, states that 20 people are still confirmed to be in jail. ### **Spotlight on Activists**

In the preceding weeks and months preparations were made in hectic circumstances. The Minister for the Interior called us terrorists and killers and the media fixated accordingly. Police patrols were set up on every street corner, day

An Earth First! samba band rehearsed on the river island under close police scrutiny. a pirate radio was set up and ticket inspectors made a killing on the metro and trams.

Away from Prague an action camp was set up for a week to provide workshops on legal, medical and political issues and the practicalities of banner making and street actions. The workshops continued in Prague at a disused docksite as thousands from all parts of the world mingled, organised and attempted to co-ordinate through spokes-council structures.

# We fought the law and - we won! So far anyway.....

Regular Loombreaker readers may remember the debacle that the cops made in trying to nab people after the Hacienda was squatted for the second time. Most people arrested on the night had their charges dropped. Two of these innocent clubbers decided to get their own back for being pointlessly arrested just cos the cops were pissed off. Granted, we'd run them ragged all day during the May Day actions, then cheekily thrown them off the scent (of over 200 people) and managed to resquat the Hacienda. And after the last time when there was practically a riot as people tried to break through the police siege to get in and dance. However, this was no excuse for the cops to randomly arrest people, so the two people sued them for wrongful arrest, and were offered a significant sum of money each by the Greater Manchester Police. Nice one!

Going back to that first squatting of the Hacienda, the remonstrations are still happening. Again, most people had charges dropped or were offered bindovers rather than fined. Except for one person who tried to defend himself against wrongful arrest, and was then charged and found guilty of assault of police officers. He was given community service and has now done this. However, seeing as he was innocent in the first place, he took his case to appeal last month - and won! The judge had to admit that the

police had been wrong to arrest him, and overturned the original verdict. And finally on the law front.... One of the last cases from May Day to come up for trial is that of Ben and Graham, two students who were arrested at the Hacienda (the 2nd time). Their trial begins on Nov 13th and it would be fantastic if people could spare an hour or so to come down to the magistrates and

support them. # Save our Baths

About 80 local people involved with a campaign to save local swimming pools gathered to demonstrate at the opening of the new Aquatic centre on Oxford Rd built for the Commonwealth games. The building of this new pool will inevitably further the closures of local pools as it is part run by a private company, which will need to respond to market forces. To increase profits it will increase pressure on the council to close other pools. Local pools under threat of closure currently include Chorlton, Levenshulme, Harper Hey, Broadway and Withington.

And what are we to make of the company who built and now run the new Aquatic Centre, SERCO, who are contracted to help run AWE Aldermaston and RAF Fylingdales and who are also one of the leading companies involved in

## Kids Reclaim the Streets

In Wythenshawe recently a protest was held by local kids against motorists who speed along their street. Messages were chalked on the tarmac urging drivers to slow down and cars breaking the speed limit were shouted at from the pavement. Traffic on Stancliffe Road has increased due to more vehicles using it as a short cut to a nearby industrial estate. The protesters, aged between six and eleven felt they had to take action as they fear that someone could be killed.

# Why bother with the IMF and the World Bank?

The impact of the policies of these institutions has been felt in all parts of the world. For instance, in the UK the treasury has been recently told by the IMF that a £22.5 billion windfall from the sale of mobile phone licences must be used to repay outstanding national debts to commercial banks. The IMF and World Bank are remote and unaccountable yet powerful international finance institutions, that primarily serve the interests of the banking sector and multi-national business. Policy is determined by unelected officials, along with represents from state government, private banks and finance institutions and the private industrial sector. Non-governmental organisations are also nominally involved.

#### The Latest Scam

You may have heard of some of the dubious projects paid for by World Bank loans or know something about Structural Adjustment Programmes (SAP's) (now relabelled as Poverty Reduction Strategies) administered by the IMF. After all, the measures are all too familiar - cuts in social spending, privatisation of state assets, deregulation of health, environment and employment law or anything that hinders 'free trade', wage restrictions, and so on. As yet, the latest scam is not so well known: Speculative assaults by the private financial sector against national currencies have seen currency devaluations against the dollar, resulting in collapsing economies, mass redundancies and debt default. Debts are in dollars meaning increased debt burden. The IMF steps in with debt bailouts, to be paid directly on to foreign commercial banks. The bailouts come with strings attached, further 'restructuring' of the economy, with the national

Export Processing Zones - a particular favourite of the IMF, are areas where deregulation is complete. Sweatshops, slums, highly polluting industries, toxic waste dumps and the complete absence of social or welfare provision are all part of the scene. From Mexico to the Phillipines...

currency and national banking institutions confiscated and in the hands of the same banking institutions that launched the speculative assault. Meanwhile millions of people are suddenly and dramatically impoverished, social spending is slashed, wages drop, the price of basic foods and commodities rise. The pattern played out numerous times in the late-nineties, particularly in the far east where 'Asian-flu' devasted countries such as Korea and Malaysia, and in Russia where the economy has simply collapsed.

## A riot of tea and cake

On 17<sup>th</sup> August assorted rabble from direct action groups assembled in St Peter's Square to drink tea and eat cake in order to make an effective protest against the passing of the Terrorism Act. It was a relatively small protest, happening at tea time, appropriately enough, and was slightly marred by the presence of some police at the square. And then there were some around the corner, and a few more around the next, and several vanioads of tooled up riot cops in side streets. And there were mounted cops too. Public contact was unfortunately lower than expected because it later transpired that the helpful local bobbies had warned local businesses that there was going to be a riot in town and that it would be advisable not to catch the bus or the tram in the vicinity.

However lots of leaflets were handed out and reaction from those who did chat with the tea drinkers was positive.

Incidentally, fuel price protestor's should be advised that as their 'threat to use action' is designed to 'influence the government' and

law defence but did allow the defences of necesity and self-defence. After over 6 hours of deliberation the jury acquited the

women of the lesser of the two charges, but were unable to come to a verdict on the more serious one.

Unfortunately for Rachel and Rosie this means they face a third trial sometime in 2001.

Regrettably we were spotted before doing anything practical, but that makes it all the more important to make our trial count. We appear in Manchester Crown Court on 8th Jan 2001. Rosie and Rachel's acquittal on one charge shows it is possible for us to get the right result. Please come down and support us. As Rachel says: "Despite the efforts of the UK government, this case has shown that the moral conscience of the British people is alive and kicking!An English jury has seen the truth about Britain's nuclear weapons system and has questioned the moral and legal legitimacy of Trident." ## Hulme Green Space to Disappear

Local residents in Hulme attended a magistrates court to object to Council plans to block up a footpath through a green, naturalised space, only to learn that the Council had obtained planning permission to lease the site for development.. Only residents immediately adjacent to the site, on Stretford Road and adjacent to Hulme Arch, were notified of the proposals and any objections from them have been ignored and disregarded. In court the magistrate ruled she could only consider the issue of the footpath in narrow terms. Concerns about quality of life, pollution, consultation with local residents and loss of green space were not admissible. Residents are aiming to obtain a judicial review of the decision to grant planning permission. However a request to adjourn proceedings to allow for the outcome of any judicial review was denied and permission for the council to stop up the footpaths granted. The application for a judicial review continues.

A huge demonstration took place at the Hulme branch of Asda (owned by gun-selling US company WalMart) organised by the Manchester Committee to Defend Asylum Seekers. Asda is one of the supermarkets that is willing to take part in the Government voucher scheme for asylum seekers. Not only is it not possible to receive change from the vouchers, the value of the vouchers is less than three quarters of the minimum benefit the government says is enough to live on. At least fifty people were present at the demo, and asked customers to staple their receipts to postcards which were then handed to the store manager. Many people did so.

# Civil Rights Caravan in Manchester

'We are not asking you to walk in front of us, because we may not be able to follow. We are not asking you to walk behind us, because we may not be able to lead. Brothers and sisters, friends and comrades, all we are asking is for you to walk beside us. All we are asking is for you to walk with us.'

On 29<sup>th</sup> of Oct, the Civil Rights
Caravan came to Manchester, in the
Longsight Pakistani Community
Centre. The Caravan is made up of
refugees, the families of victims of
racist attacks and support
campaigners, travelling around the
country to raise awareness and reach
out to communities around Britain. The
above quote is from the speech of a
Tanzinian refugee living in Salford.
Subjected to imprisonment and abuse
he is still ready to resist and to
organise against the UK asylum
system.

'I speak from experience, but others from experience, do not speak.' Too often the ones most at risk are those with no voice. The Civil Rights Caravan has been trying to give refugees and victims of racist attacks a way to communicate with various communities around Britain. The Caravan has been set up by the National Civil Rights Movement (NCRM - set up by members of the Lawrence Family campaign) and the Campaign Against Racism and Fascism (CARF).

The Southall Monitoring Group in London has been very successful in tracking police and other racists and supporting the victims of abuse. Hopefully a Manchester Monitoring Group would be similarly action-based, rather than another forum for chinrubbing. Contact CARF or the NCRM for more details.
