THE DRAGON SPEAKS

Well, once again it's time to get on the machine and talk about recent developments here and there. This issue is primarily set up to reflect our particular theories and philosophies as related to these issues. A great deal of thought has gone into these essays and a great deal more will be forthcoming as situations change and we correct inaccurate data or badly structured ideas.

Right now we are engaged in a touchy situation in prison. The State is attempting to screw the citizens out of hard-earned cash to build new prisons. The Administration of these prisons wants tighter security, more authority to manhandle and intimidate the inmates, and, of course, more money for less work. There are only a limited number of ways these goals can be accomplished.

The situation is getting volatile. What little privacy we once had is being eroded as much as possible. Since a New York court shot down the skin-search rules, these searches have reached an all-time high here at the Walls. The reason is obvious. Since the cons here know that it's illegal, the humiliation involved is increased. The more humiliation a man is subjected to, the greater tension he is placed under. When he finally blows up, the Administration has all the excuse it needs to come down hard on us all.

Another problem is the overcrowding. This place is so full that people are being placed in Protective Custody (PC) simply because there are no available houses. This puts a "snitch jacket" on the man, and if he is ever released from PC, he better have a damn good reason for being there. That is, if he has the time to explain it to people. He just might get killed before that.

Other problems here are the burglaries and break-ins perpetrated against inmates by the Administration. FUSE (Felons Unification for Self-Endeavor), was recently broken into and valuable property removed from their offices. FUSE has been active with a lobby in Olympia and has recently submitted legislation to alleviate the oppressive conditions here and at other prisons throughout the entire State of Washington. The "contraband" confiscated was a collection of the proposed legislation and evidence supporting their allegations against the Administration.

This evidence included the facts pertaining to the shooting of two inmates (unarmed) attempting to escape through a tunnel dug under the west wall. The Administration knew about the planned escape a month before it happened. They made no attempt to stop it. They simply waited to shoot the escapees as they made their way out. Then they released a cover-up story to the press that showed the guards as heroes. Nobody asked the escapees for their version of it.

Another problem is the secret file kept on prisoners. Anything can go into them. The prisoner is not allowed to see them and is thus either unaware of the accusations being made against him or is simply powerless to correct them. Washington State is of the opinion that the Freedom of Information Act does not cover them.

This puts the prisoner in two bad situations. The first is that he is often subjected to a greater amount of time in addition to a minimum sentence that he has already served. The second is that, because of the erroneous information contained in these files, he is subject to be murdered by the State upon his release. Since he is usually unaware of these files he is not in a position to defend himself against any actions perpetrated upon him. If the record is found to be in error after he is dead, the usual excuse is that the State agents involved had no way of knowing that at the time. "Sorry bout that, fella."

This brings us to the question about what can be done to remedy the situation. The answer is, "Not much." The only things we can do against attacks on us while we are incarcerated are usually confined to passive and peaceful resistance. Submit to skin searches under protest. Keep clean. Get rid of any weapons

the guards may find. Fight every bust. Write letters to friends, family, and representatives informing them of all the details of the intrusion. Contact the metasentatives inform support groups. Record everything. If you see someone being harrassed dia. Inform support groups. Record everything. If you see someone being harrassed by the guards, stay around and be a witness. You are then subject to the same indignity, but it makes our position a bit stronger and the State's weaker.

Some groups and individuals have gone so far as to suggest sabotage of the State's property. These suggestions have ranged from such simple acts as throwing away tools and eating utensils, loading up the sick call lists, and taking your time doing whatever it is you are doing, to pouring abrasive compounds in State vehicles, stealing records from the Administrative Offices, writing up infraction reports on guards, and flooding the courts with writs and suits. Some people have even begun to study the law, then turned around and used the State's law against it.

Whatever you decide to do, do it in a peaceful and friendly manner. Do not threaten the guards. Actions like that only strengthen their position while they weaken ours. But, if we resist the State peacefully, especially if we challenge them in their own courts with their own laws, we can bring enough heat down on the system that it will be forced to re-access its position. Show the citizens that a great amount of crime is perpetrated by the guards against the prisoners. If we can do this, we will win.

They have the guns, but we have each other. Defeat the State by the State.

oil power politics

POLITICS 15 about power: that is true whether one is talking about the Socialist Workers' Party, the Libs-Labs-Cons, the Scottish and Welsh Nationalists or the National Front. To attain power one must acquire a large amount of popular support and there are of course various ways of doing this. The most important way in the West is the distribution of goods and services to the population at large. In this matter, it is expedient, in dealing with the major sources of wealth, to use them in the shortterm interests of power politics. People are led by the whole spectrum of political power-seekers, to believe that it is necessary to have a sophisticated political power structure to deal with the complexities of resources, production and distribution. The truth is the opposite; for in the interests of political expediency within a generation or two the whole earth has been despoiled one way or another.

OIL FOR THE POLITICAL MACHINE

In a Guardian Special (Nov. 19) an article with the headline 'Oil cash could lead to tax cuts' ends with the following:

Two of the main dijectives are to restore

falling living standards and to provide employment by reinvesting in industry. Senior union leaders and Labour Party members who received the document ('How Shall We Take Advantage of the Benefits of North Sea Oil') yesterday looked on it as an attempt by the Government to get over the first hurdle of winning the election with the promise of more tax cuts.

There we have it in a nutshell, for although the document suggests that some of the money be spent on the inner cities and the underfives, it is obvious that the probability is that it will usher in a new period of 'never had it so good' with its attendant drain on resources.

WASTED OIL

"Mr. Benn and Mr. Healey" says the Guardian article, "begin by saying that North Sea oil will put Britain into a balance of payments surplus again 'and a new source of Government revenue'." What will happen is that the oil will be consumed as rapidly as only a modern industrial state knows how, like the farmer who uses everything and does not save enough for seed. The We in the document, of course, is supposed to mean all of us but it is

quite obvious from the statements of our ruling politicians that they know who they mean by 'we'. When the monster has gobbled up the oil then it will have to be sustained by large amounts of nuclear-based fuel, of which the dangers are becoming well known.

WHAT DO ANARCHISTS SAY?

In the words of Murray Bookchin, 'Pollution is the destruction of life by an out-moded system based on individual survival', and Messrs. Healey, Benn and Calloghan have no intention of changing such a system. Anarchists say that resources must be shared and carefully conserved, which presupposes a revolution in the production of industrial and agricultural goods, in the development of services. It means a reversal of the idea of continual industrial growth and larger and larger social units with their waste and inefficiency. The movements all over the world for the regions to have more say is an indication of some appreciation of the necessity of this Is gaining ground. Anarchists believe that organisation is possible without authority and that it is the authoritarian part of the organisation that causes the problems that face the modern world. If we husband our resources we must be close to them to understand them, and this is only possible if social organisation is small and everybody is directly concerned.





Walla Walla Inmates Sue

The Washington State Coalition Against More Prisons reports that inmates of the Intensive Security Unit at Walla Walla prison have filed suit against the State's Department of Social and Health Services.

The prisoners complain about civil rights violations and hope to get an injunction to stop the use of box car cells and arbitrary strip searches.

The box car cells, which the prisoners say they are often subjected to, consist of a concrete box with bars spaced one inch apart. A solid steel door beyond the bars blocks off all sound, fresh air and light. Chief Judge James Forman ' of the Eastern District in Illinois ruled, recently, that this sort of sensory deprivation resulted in both mental and physical deterioration and 'unnecessary pain and suffering."

Strip searches, allege the prisoners, are routinely and arbitrarily performed by the guards. They complain that the searches are degrading and dehumanin the mount of the property with the



Prison: Riots or more aid, solon predicts

Large-scale prison rioting could hecome a factor at Monroe Reformatory or the Washington State Penitentiary at Walla Walla if the state doesn't spend more money on correctional institutions, State Sen. A.N. (Bud) Shinpoch, D-11th District, predicted this week in Kent. ..

"The state is going to spend one hell of a lot of money cleaning it (the correctional facilities) up or we're going to go through an Attica or a McAllister," the Renton Democrat told members of the Kent Rotary Club during a speech Tuesday on issues of the upcoming session. eastside legislator Hubert Donchue, D-Dayton.

The \$10.2 billion in state expenses outlined the governor also will come under scrutiny, Shinpoch indicated.

"I'm not sure the increase the governor is proposing is appropriate," he said candidly. "I'm not sure that because the money is there we should spend it," he added, referring to the governor's projection of increased revenue for the state during 1979 and 1980.

School issues will consume a "tremendous amount of time" in the coming session, particularly in the

The comment came during questioning about the budget for the Department of Social and Health ·Resources. Attica is a New York prison that gained national attention in the early '70s when rioters took · control of the facility. More recent-·ly, at McAllister, Okla., inmates 'rioted and "burned the whole place" to the ground, Shinpoch said.

Prisons were only one area to which Shinpoch said the Legislature may turn its attention when the -session opens next Monday at Olympia.

Budgeting will be a key issue and one which the former head of the House Appropriations Committee said could not be completed in 60 days as contended by Gov. Dixy Lee Ray, Shinpoch said. He said he believes the \$250- to \$300-million surplus forecast by the governor, if correct, will be spent on a tax reduction. And he predicted a reduc-· tion in the property tax would take the form of "some combination" of proposals by the governor and by

areas of a lid on school levies and on "providing equal financial opportunity for education to every child in the state."

In that vein, he said Kent and Renton school districts will be "slightly better" for state support, while districts such as Tacoma, Scattle, Mercer Island and Bellevue will fare worse under state funding appropriations.

Shinpoch also commented on the 49-49 split in Democrat/Republican membership of the House that left the speakership split between Democrat John Bagnariol, also of the 11th District, and Republican Duane Berentson.

"The B & B love-in can't last," heclaimed, adding that it would not be one of the major issues that disrupts the co-speakership, but "some small one, (over which) the caucuses will

come part. "And whether the leadership can control their caucuses to shut the place down and get out will be an interesting question."

People come together because of need, the more they are involved the more they trust each other and communicate with each other. The more they care the harder they work for the common good, the stronger their numbers are.



CAPT. KILLJOY

The Captain (one of a few, by the way) is simply an over-age Yippie-type who never learned that Individualism and Anarchy are impossible to accomplish. In practice he is strictly an Egoist, believing in the Stirner philosophy of, "I know I'm cool!" His basic political ideas are best expressed in his own words, "I know, I know." The rest of the Collective often wonders exactly what he does know.

'VIOLENT' WOMEN

Over the past several years criminal justice officials have promoted the notion that there is a "new breed" of violent female criminal. Judges have responded with more prison sentences and longer sentences. Corrections officials have responded with behavior modification programs and special segregation units.

It is simply not true that greater percentages of women are committing violent crime. Figures extrapolated from recent FBI statistics indicate that female arrests for violent crimes (defined as murder, robbery, and aggravated assault) have actually decreased from about 12% of the total arrests for those crimes in 1960 to about 8% of the total in 1975. In the last several years, there has been a trend towards a decrease in the crime rate, due to changes in the birth rate. Experts anticipate that the overall crime rate will continue to go down.

Of the small percentage of violent crimes that are attributed to women, many constitute acts of self defense against physical abuse by men. Two phenomena seem to be occurring: first, a reasonable and legitimate response to life threatening violence by men; the Joanne Littles, Inez Garcias, and Yvonne Wanrows would not have been seen as victims to be supported through their prosecution twenty years ago. Second, more women seem to be fighting back, Men, it should be noted, have not become less violent. In a five year period from 1970-75, arrests for rape across the country increased about 48%. A breakdown of the victims of homicide by sex reveals that about 89% of all female murder victims in 1976 were killed by men (about 21% of all male victims were killed by women). The percentage of men arrested for violent crime has increased about four times as much as the percentage for women over the past two decades

Clearly there is not a "new breed" of violent woman, only a ne attitude towards women within the criminal justice system. In Calif ornia, prison officials created the A.P.U. (Alternate Program Unit) fol "disruptive" women prisoners who were "disciplinary problems," who refused to work or who had a negative influence on other cottage re idents. In New York, prison officials shipped "troublesome" women prisoners from Bedford Hills prison to a wing of the state mental hospital for the S.T.E.A.D.Y. program (Steps Towards the Eventual Acceptance of a Disciplined You). In Massachusetts, prison officials are trying to build a special consultation and treatment unit for women prisoners in a wing of the Worcest State Mental Hospital. And in the Federal system, we have the Maximus Security Unit at Alderson, West Vi ginia.

The facts flatly contradict the assumptions upon which these maximus security units have been based. The actual purpose for these prisons—within-prisons is to isolate and control prisoners who gain "notoriety" or are politically active with in prison

in prison.

In 1976, Bureau of Prisons officials revealed, in off the record remarks, that a new control unit was being built specifically to hold Sara Jane Moore and Lynette Promme, both convicted of attempting to assassinate then-President Gerald Ford. Recently, Rita Darlene Brown self-declared member of the George Jackson Brigade, and a state prison or sentenced to 25 years, was sent to MSU at Alderson. Soon after,

murder in New Jersey, joined Rita.

MSU at Alderson was created as a lock up for the most unwanted,

"troublesome," "notorious" and politically active women in the prison system. It is a way to cut them off from their primary sources of support, their legal team, their family, and from other prisoners.

THE COMMUNIST QUESTION

Over the years Anarchists have looked for help in their never-ending struggle to bring about a world of total freedom and equality for all people. This search has oftentimes led to death, frustration, and the dungeons of the local prisons. As Anarchists, we are often familiar with the feeling of being alone and greatly outnumbered, but we constantly look for ways to relieve ourselves of the "it's me against the world" syndrome. One of these ways is by aligning ourselves with a powerful force that appears at our side during these bouts of depression. This force is the Communist cell.

Communists hardly ever call themselves this anymore because of the unpopular connotations linked to this political philosophy over the years. So Communists are



getting in short supply. However, any neighborhood will yield its share of Marx-ist-Leninists. That's the "new" name. They are coming out of the woodwork like never before. "We are the real revolutionaries.", they will tell you. "Everything for the good of the people."

Well, it just ain't so. You can put a beautiful coat of metalflake paint on a pile of bullshit, but that in no way stops it from being bullshit. A Communist by any other name is still a Communist. They speak of the "will of the people", but when they have their turn at bat they suddenly forget the promises of freedom that they made to the masses. They conveniently forget that it is the people who know what the people want. They forget that the people were promised the right to govern their own lives. They claim to be the "servants of the people", yet they forget that a servant does not dictate to the master.

By aligning ourselves with Communists, no matter what the circumstances, we are putting ourselves in jeopardy. We must let our allies know our actions to some degree, but the Communists have a bad habit of being political opportunists. Let them know what your plans are and you will suddenly find out that they have developed a "brand new program" that has a very familiar sound. And for some unexplained reason you are suddenly the villian.

Communists love to organize. Let one into your cell or organization and shortly more will be in. As soon as it happens you can bet your favorite freedom that there will be a take-over and the Anarchists will be left out in the cold. The Anarchist program, reputation, and even his essential liberty will be taken and used against him. If the program fails, as they so often do in Communist hands, then the Communists point out that it was an Anarchist group that failed and that "the valiant efforts of the vanguard of the revolution" were too late to save the program.


Manipulation is one of the strongest games that the enemy can play, and Communists are masters at it. He knows that if he mouths the words that the people want to hear often enough, he can appeal to their vanity rather than their good sense. He will employ this technique well.

What more can be said? Are you an Anarchist? Do you identify with the Left? Then it should be apparent to you that any political group other than Anarchy is right-wing. Does it appear that Communism is "the lesser of several evils"? The same can be said of lung cancer over leukemia. But both will still kill you.

Do you advocate "the will of the people"? Then we must assume that Hitler was right because the majority of "good Germans" went along with his programs.

But if you are an Anarchist and believe that all people are entitled to the benefits of freedom, then you will not allow yourself to be taken in by the rhetoric of any other political system. So be an Anarchist. Stand tall and tell the Communists to pack it up.

Look at history. It will tell you the same thing.

Prison inmate slain

FLORENCE, Ariz. — An Arizona State Prison inmate was killed and three other inmates were wounded today when a prisoner with a history of psychiatric troubles opened fire in a cellblock, authorities said.

The assailant was identified as Roman Stone, 26, serving 15 years to life for kidnapping and armed robbery. Identity of the dead man was not released.

"How he got the gun, we don't know," said Carolyn Robinson, a Department of Corrections spokeswoman.

The episode began when Stone was being moved from a cell to the prison barbershop, she said.

"He broke from the escorting guard and ran up the tier to the screened walkway, shooting the gun," Ms. Robinson said.

She said Stone, using a .25-caliber handgun, began shooting, hitting four inmates who were locked in their cells. He was taken into custody after he ran out of ammunition, she said.

NEW YORK, Jan. 5—A Federal District judge in Virginia today awarded prisoner Henry Tucker \$518,000 for irreparable physical damage done to him while he was imprisoned in the Virginia State Penitentiary.

After receiving massive doses of the drug Prolixin, Tucker developed a severe neurological reaction, first experiencing tremors and then slipping into a stupor in which he was immobilized for six months. Prison doctors made no effort to diagnose or treat. Tucker's condition. During this time without medical treatment he lay covered with maggot-infested bed sores.

His hip joints were so badly affected that they froze with his legs drawn up against his chest making it impossible for him to lie flat or sit in a chair. His hip joints actually had to be surgically removed later in order to enable him to use a wheel chair. He has lost the use of his legs and his arms are paralyzed.

"It was like something out of the Inquisition," said Steven Bricker, one of Tucker's lawyers.

The terms of the cash settlement allowed the prison ad. ministration to avoid admitting responsibility for destroying Henry Tucker's body. Tucker's lawyers have stated that the amount of the award (few of the 5,000 prisoners who sue the prisons every year are awarded a cent) showed that the prison officials who head the state prison system felt that they would lose a jury trial, and that this settlement was meant to avoid a more embarrassing political problem if the trial received attention.

Another question raised by this case, although not dealt with in the suit, is why Tucker was given the drug in the first place. Prison officials claimed they administered Prolixin to "pacify" Tucker after he had been denied parole. What gives a prison administration the right to pump a prisoner with powerful drugs? Does anyone think a landlord has the right to drug a tenant angry over a rent increase or that a boss has the right to drug a worker who feels that he or she deserves higher pay?

drugs (Thorazine) which were forcibly
adminsitered to me by jail guards at
the Fulton County Jail in Atlanta,
Georgia, where I had been confined

consciousness to such an extend that I don't know what was going on at the trial, and the next thing I knew the jury said "Guilty". But the whole thing is that the Judge, United States Attorney, and my State-appointed attorneys were fully aware of my "dopedup" condition, but they deliberately allowed the trial to be held anyway. To add to this obvious injustice, the attorneys appointed to represent me were totally incompetent, unconcerned and uncooperative; they actually collaborated with the government in covering up the facts of my torture and kidnapping by government agents, and helped to quietly convict me. Over my strenuous objections and taking advantage of my drug-induced confused state, these attorneys asserted an "insanity" defence to the charges,

stating that I was "temporarily insane" at the time of the "crime." They did this so as to stigmatise anything I might say, no matter how shocking, as the "ravings of a madman." Thus no one would believe me when I told them my story, until years later, when the CIA and FBI admitted such crimes.


It is thought by those brothers and sisters who are starting the project that this might be also an organisation for the propagation of libertarian communist views in the African revolution too. Our comrade Lorenzo Komboa Ervin — now in his ninth year of imprisonment for "war cromes" — i.e. opposing the Vietnam War — writes:

"Right now, as you know, Marxian "State Communism" predominates in the African Revolution (and in fact the whole anti-colonial/anti-racist, antiimperialst struggle world-wide!) This is because libertarian communism has not been consistently and properly propagated to the oppressed masses of Africa, Asia, Latin America and Oceania (or even Europe and N. America for that matter!) State "Communism" has really been unopposed, and actually adopted for want or knowledge of any alternative. As a result people look upon the regimes in China, Russia or Cuba as "communist workers' states." They don't know what true communism is and thus react very negatively to anarchist communism. On the other hand some react negatively to the very idea of communism, thanks to the State dictatorships of the Stalinists.

To me and those who know better, especially those libertarian communist revolutionaries, it is our responsibility to propagate and struggle to make the truth know. The future is anarchist."

Lorenzo is typical of many young revolutionaries who went into action thinking on Marxist-Leninist; or Third World lines, but who have become anarchists as a result of their experiences in struggle and in jail. These range through many nations and the number is now formidable. The project of an international black tevolutionary organisation is historic. It is not the first black Anarchist movement. But in a previous generation black revolutionaries thought that as we are opposed to nationalism they should make nothing of their origins. It was quite unknown, for instance, that Lucy Parsons was black, or mostly so.

They were ideologically correct, but they made no impact. Now, Black militants realise it is necessary that Black workers understand their identity.

'Shell Game' Dumb, Weapons Man Says

WASHINGTON — One of the government's foremost weapons experts says the so-called "shell game" proposal to scatter U.S. ICBMs among many empty missile silos would be "dumb."

Dr. Harold Agnew, director of the government's highly sophisticated weapons development laboratory at Los Alamos, N.M., denounced the multiple-aim-point (MAP) basing system during a speaking engagement here.

Under the MAP proposal, 250 ICBM's would be rotated through a system of 5,000 missile silos to keep the Soviets from knowing which holes were loaded and which empty.

The idea stems from the fact that Pentagon experts believe the present U.S. system, of keeping the land-based missile arsenal in hardened silos whose locations are known to the Soviets, will be vulnerable to destruction by improved Russian missiles by the mid-1980s.

By then, neither side will be able to fortify a missile installation well enough to withstand an attack by increasingly powerful and increasingly accurate ICBMs. Hence the suggestion to hide the U.S. missiles among vast fields of empty silos, and keep moving them around.

"I think they (the Soviets) would be delighted" if the U.S. were to make a tremendous investment in 5,000 holes in the ground "with the assurance that there is nothing in most of them," Agnew said.

As an alternative, the Los Alamos expert urged that the U.S. retain its present fixed-base silo system, but greatly increase its intelligence surveillance of the Soviet Union by satellites orbiting in space.

This would cost "10 times less" than such mobile basing systems as MAP, he contended, yet it would ensure detection of any. Soviet ICBM attack in time for the president to fire U.S. missiles in retaliation so they would not be caught and destroyed in their silos.

The cost of the MAP system, together with the 250 next-generation MX missiles which would be used in it, is estimated at from \$20 billion to \$30 billion.

A suggested alternative mobile basing system is to develop new planes to carry the MX. The planes would take to the air at any alert of a Soviet attack, then land at some secret spot from which the missiles would be launched at the Soviet Union in retaliation. But this method is estimated to cost a staggering \$50 billion.

It is the Air Force which contends that the U.S. ICBM force must be switched to a mobile-basing system to ensure that it will not be destroyed on the ground. But both Defense Secretary Harold Brown and President Carter are known to be unsold on the idea, although Carter has ordered the Pentagon to speed up its research schedule and recommend a basing system decision for the MX by next April 1.

Agnew, a nuclear weapons pioneer who worked on the first nuclear fission chain reaction in 1942, is the most prestigious technocrat to argue publicly against the switch to a mobile basing system.

He argued Wednesday that, so long as the president maintained the U.S. deterrent by vowing to order a retallatory strike the moment he learned Soviet missiles had been launched, there would be no danger of fixed-base. American missiles being destroyed on the ground.

A CRITIQUE OF ANARCHIST SEPERATISM

In reading articles and books on modern Anarchist theory, I keep stumbling over references to Anarcho-this and Anarcha-that, as though there were distinctions to be drawn between men and women politically. This only causes divisions to exist among Anarchists that really should not be.

Anarchists have always been in the foreground of any battle over the rights of individuals. I hear you saying, "Please, don't bore us with repetitious recitations of basic Anarchist theory. We know that already." Perhaps it is true that this statement is repetitious. Perhaps we have heard it so many times that it has been drummed into our heads as a meaningless phrase. But perhaps, too, we have forgotten the meaning of these words.

There are basic differences in men and women, both on the physical levels and the mental/emotional levels. Both bodies and minds operate differently. It is also true that we are guilty of stereotyping if we rely on this single arguement. We must carry it through, then, that people act differently and are, therefore, completely unique. Here we find ourselves dealing with others on an individual basis, a one-on-one confrontation.

In a one-on-one confrontation there are no barriers of race, sex, or any other walls to impair the Anarchist from productive work and dialogue. We deal with individuals, with single parts, with people eye to eye. To deal with factions defeats us. It weakens us, both physically and in our relationships with others.

Let us reason this out. Do you, as an Anarchist, believe that a person has a right to choose the life they see fit? Of course you do. Does it matter, then, whether the person choosing is a man or woman? Certainly not, for if it did we would not be Anarchists. If we practice a form of supremism, then we are Supremists. Man or woman, we must support the rights of individuals to determine their own destiny, irregardless of sex. The only time sex is a determining factor in Anarchist thought is when we are indulging in it. Even then, it remains on a personal level of interrelationship.

By definition, then, we find that all Anarchists are Feminists to the extent that we support individual sovereignty. So there is no distinction. Why create a faction that does not exist except in the minds of those superficially involved in Anarchism? Are we to destroy ourselves over arguements that are but figments of our imaginations, and that exist not at all? Are we to spend precious time, great chunks of our lives, argueing useless ideas? As Anarchists, we no doubt support one's right to indulge in foolishness, but that in no way says that we must indulge in it.

Women for centuries have been located mostly in the home. Does this mean that women are meant exclusively as housewives? No. Witness the many women throughout history who have been engaged in battle, commerce, and all the other fields of life. Sure, they are small in number, but is that because most were kept locked securely in the house while the "man of the house" was out? Of course not. Many of the examples of women in these fields are mentioned because of the exceptional circumstances of the times, or the extreme "heroes" created for exploitation. If women should not be exploited in the home, it follows that they should not be exploited at all. What is the difference, then, between these two extremes? None.

Or of the men. We do not hear of all the men who have toiled for the cause. We are more likely to hear of those who have realized great goals, rather than the ones who labor day to day in their chosen fields. And how often do we hear of those men who stay home and raise the children while the woman earns the daily food and rent? Hardly at all, unless they are held up as examples of a false equality or as objects of ridicule by their "macho" friends.

Friends, we all have our talents, our capabilities, our strengths and weaknesses. We all have our desires to reach our goals. Is it really that important
whether we are men or women? Isn't the basic idea behind Anarchism the cooperation
of individuals toward a more enjoyable existence.

Promoting the existence of Anarcho-this and Anarcha-that is self-destructive. It is a contradiction that our enemies shall grasp and wield against us as a sword. If the Feminists speak only of the great achievements of women, aren't they indulting in sexism? Isn't this type of activity simply another facet of Supremism? Are

we to promote, once more and in our own ranks, the theories of the "seperate, but equal" fallacy?

Let us, therefore, leave the path of seperatism and join our hands and efforts in the common goal of individual liberty and mutual understanding. Only in this way can we honestly say, "I am an Anarchist." Only in this way can we show our policies to be those of true respect and total solidarity with each other. But while we make distinctions between ourselves on the basis of sex we are showing that our words are nothing and our lives a contradiction.

Are you a man? Take pride in your masculinity, but be sure that you know what true masculinity is. Are you a woman? Be proud of the attributes of woman-hood, but do not deceive yourself as to what is feminine and what is not. Men and women, know your strengths and weaknesses. Know that the strength of one is sufficient for many tasks, but the strength of two is greater. Does it really matter if one of those arms is a man's or woman's? If we pull together we attain a common goal. Is it more important whether men or women reach it? Or is it more important that we all enjoy the benefits of our labors?

I leave the answers to your discretion. Anarchists must study to know what Anarchism is. Anarchists must practice this way of life each and every day. And Anarchists must think through what they study and live. To accept anything on the unsupported testimony of one person is the sign of a fool. Another sign is to accept anything without examining it in all its many facets and appearances. We may support a person's right to be a fool, but we do not have to help him in his foolishness.

Think about it.

Grass War = Class War Mexico's Struggle For Land

Behind the hype and hysteria are the real victims of paraquat sprayings: poor Mexican farmers. The spraying has its roots in Mexico's land war.

For the past decade landless peasants have been occupying and farming some of the immense haciendas legally owned by Mexico's feudal aristocracy. Landlords have hired bands of pistoleros to remove the squatters, but the peasants have armed themselves also.

In December of '76, outgoing Mexican President Luis Echevarria, as one of his last acts of office, issued a decree giving legal title to hundreds of thousands of acres of occupied land to the squatters—including acreage taken in a massive wave of seizures in Sinaloa just before the change of Ad-

ministrations.

President Lopez Portillo, Echevarria's successor, is closely tied to banking interests and the land-owning aristocracy. Not surprisingly, his backers are not pleased with passage of title to those who work the land.

Paraquat spraying has been used only in Sinaloa State, Mexico, in a plot by the vested interests to drive uppity peasants back off the land. Ofcourse, a lot of Mexican pot comes from Sinaloa, which is relatively close to the US, and bigger than California. Large marijuana rancheros

elsewhere can afford the payoffs necessary to avoid being sprayed. It is only the impoverished peon who grows just enough corn to feed his family, with pot planted between the rows as a cash crop, whose family is being deliberately poisoned thru their food like cucharachas.

The scene is chillingly reminiscent of defoliation and the US "resettlement" schemes in Vietnam: his food crop as well as his pot crop destroyed, our peon is forced to look for work, joining the army of unemployed rural laborers. The land reverts to the banks, and then the feudal latifundistas.

It's no coincidence the Mexican spraying program utilizes paraquat instead of Agent Orange, 2-4D, or any of the other poisons so popular in Nam. Paraquat is the "neutron bomb" of defoliants. Unlike the others, which can leave land barren for twenty years, paraquat breaks down in the soil rather quickly.

The Americans in Victorian knew they would be kicked out, and had no qualms about leaving the countryside a wasteland. Those who are running the Mexican program expect to be planting the land themselves next year, and use the highly degradable paraquat.

IN DEFENSE OF OURSELVES

Recently the newspapers have been telling us details of an expected plea by Patricia Hearst to further her fight for freedom. The plea is called "coersive persuasion" and is somewhat akin to the brainwashing defenses we see so often in related instances and circumstances such as the Korean and Viet Nam Wars.

Richard Delgado, a member of the University of Washington law faculty, describes the elements of this technique as "unusual or abnormal influences, including drugs, hypnosis, prolonged confinement, physiological depletion, and deliberate manipulation of guilt, terror and anxiety." Under any of these conditions a person can be made to see and believe almost anything. Such a person would, of course, be the unwilling victim of these manipulators.

Since this person, subjected to these stresses over a length of time, would not be in full voluntary control of their faculties, they could not be held responsible for any criminal acts committed by them. They would be exonerated from all guilt by virtue of the fact of coersion.

The theory further implies that anyone employing such techniques is guilty of terrorist activity. The usual example related is, of course, that of Patricia Hearst and the Symbionese Liberation Army, a group of individuals the government and media insist on calling terrorists. This example is used to demonstrate the power one group can hold over an individual who has the misfortune to be under the complete control of the aforementioned group.

Let's look again for a moment or two at the definition of "coersive persuasion" and attempt to determine what widely known groups fall into this definition. "Unusual or abnormal influences, including drugs, hypnosis, prolonged confinement, physiological depletion, and deliberate manipulation of guilt, terror and anxiety."

So much for the techniques. Now, where can we find such deeds that can turn an otherwise rational individual into a personality in conflict with established social norms? The answer is simple, straightforward, and enough to scare the hell out of any decent human being. Jails, prisons, mental hospitals, behavior modification units, parole programs, old folks homes, and various other activities fit this description quite well.

If we assume that these techniques are used by terrorists, we can assume that anyone employing them is a terrorist. Since no decent person would wilfully use these techniques on another human being, it becomes obvious that this is indeed the case.

We can therefore conclude that these people running the prisons, mental health facilities, etc., are terrorists.

Well then, where do these people get their authority to commit such atrocities on other human beings? There is only one source of this authority in this country or any other. It comes directly from the government institutions that set up, coordinate, finance, and subsidize these establishments. In effect, then, we find that the government is subsidizing terrorist acts upon its own citizens.

This shows that the government wilfully and knowingly gives aid and assistance to those that would harm the free citizens of this country. This is in direct conflict with the role of government as described in the Declaration of Independence and the Constitution of the united States of America.

The Declaration of Independence states in the second paragraph, "That to secure these rights," - Life, Liberty and the Pursuit of Happiness - "Governments are instituted among Men, deriving their just powers from the consent of the governed, That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness."

The Constitution states in the preamble that it was established "...in order to form a more perfect Union, establish justice, insure domestic tranquility, provide for the common defence, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity ... "

These documents, upon which this country claims to base its very existence, state clearly that such tactics and techniques cannot be tolerated by anyone who cherishes the concepts of Freedom and Individualism. Yet we see that every day these rights are betrayed and trampled upon by those who voluntarily swear to uphold and protect them. Every day we and our families are terrorized by the agents of this government. Every day citizens are subjected to undue anxiety and "treatment" by drugs. And such practices are upheld by the government of the united States and the various individual States.

It appears quite obvious on the face of it that the established government exists solely to exercise its power over sovereign individuals, continueing by its military strength and the stupidity, apathy, or timidity of its citizens. The government of today is nothing more than a parasitic entity that survives on the blood of its victims and continues to survive simply to destroy its citizens. If such were not the case, our prisons would not be overcrowded, our hospitals would not be overflowing with sick people whose minds have been destroyed by the government and its actions, our young people would not be imprisoned in social monstrosities by these powers, and our aged would not be dieing in prisons calling themselves "old age homes."

We cannot tell you what to do so that these things can be abolished and sanity can once again be brought to the front. The choice you make is entirely up to you. If it appears that this government is abusing its powers and no longer serving the people, then it is your duty to "alter or abolish it. It may very well be your only way to survive.

INTERNATIONAL PRISON FAMILY

Hapotoc: "Playing to win"

HAPOTOC International Family (Help a Prisoner and Outlaw Torture Organizing Committee) is no ordinary prisoners' aid organization. It's an explicitly anarchist group aiming to eradicate the social conditions which give rise to crime, violence, prisons, police forces, armies and dictatorships of all kinds.

Unlike Amnesty International, which aids only non-violent prisoners of conscience, the Amsterdambased HAPOTOC works on behalf of any prisoner, no matter what the "crime" may have been, with no distinction made between political and economic offenses. The reason: crime and prisons were born when State/class society was born, and they can only be overcome when State/class society is given its final push into the dustbin of history.

Win people to anarchism by getting them involved initially in individual cases, by encouraging them to correspond with or about selected prisoners. This involves them in the prisoners'

struggle, and exposes the true face of the State, which is normally hidden from view. Prisoners involved with the organization are encouraged to work on behalf of other prisoners, thus developing solidarity.

Membership in HAPOTOC is informal; there are no rolls kept, but there are special subgroupings:

Crusade Against Torture),
Box 22523, Fazantenhof,
Bijlmermeer, Amsterdam,
Netherlands, deals
specifically with cases of torture, behaviour modification,
and the death sentence. This

Another sub-grouping, ICAP (International Crusade Against Prisons), Box 27087, 1002-AB, Amsterdam, Netherlands, deals with prison conditions, life imprisonment cases, and prison slave labour.

HAPOTOC began when

Michael Tobin, currently based in Amsterdam, was arrested in England for issuing a leaflet calling on British soldiers to desert. He pointed out that the soldiers were only workers with uniforms on, and should join with the Irish workers to fight against the fascists in Britain as well as in Ireland. Tobin's defense committee finally forced Amnesty International to take his case after they had initially refused. After his release, Tobin worked on other cases with AI, but soon discovered an overly cozy relationship between some elements in the group and the British government.

This confirmed the need for a new transnational prisoner organization. So HAPOTOC was formed in September 1974, with a manifesto published in the summer of 1975. At this time they had a few score prisoners—almost all inside for "criminal" reasons. Then in October they got an urgent appeal on behalf of Marie and Noel Murray, imprisoned for their beliefs by the Irish republican govern-

ment, and helped launch an international support campaign.

But the vast majority of HAPOTOC's work is not with name prisoners. Much of it is money and time consuming — writing letters, photocopying documents, making contact with prisoners and support people and sending them money and stamps.

As their message to new readers of Rebel, their English-language newsletter, states, "HAPOTOC adopts a positive attitude to struggle. We are not interested in skulking in corners or in becoming martyrs. For we are playing to win. We think it is time that the criminal rulers of States were made to struk in corners. We think it is time that their sick social system was buried in the pits of history."

escapees were victims of attempted murder and conspiracy to commit murder, KREM reported.

The group said prison officials knew an escape was planned, that location of the tunnel was known, and that prison guards were lying in wait outside the walls to shoot when anyone came out of the tunnel.

Spalding had said the two inmates were shot after they dischayed orders to halt and started to run. A third inmate, Arthur St. Peter, who was armed with a 38-caliber pistol, stopped when ordered and was not shot.

Spalding said guards were outside the walls Tuesday as part of a beefed-up patrol

ordered when he learned of escape plans:

Lou Fritiz, president of FUSE, said he understood that prison officials could have committed a felony by knowing of the planned felony offense and allowing it to occur.

The inmates' group also alleges that Agtues and Gilchrist were shot by guards after they raised their hands in surrender.

Spalding said he welcomes an investigation into the incident, but denies prior knowledge of where the tunnel was or who would emerge in the escape attempt.

Along with prison officials, the prison group names Gerald Thompson, head of the Department of Social and Health Services, and Gov. Dixy Lee Ray in the alleged conspiracy.

FROM THE ASSOCIATED PRESS (Bismarck, North Dakota): The North Dakota Supreme Court has upheld jury verdicts against the city of Bismarck and a former Bismarck police officer in the hanging death of a 21 year old Wilton man.

A Burleigh County District Court jury found the city negligently responsible for the death of Kevin Falkenstein, who authorities siad hanged himself in a city jail cell, Feb. 21 1975.

The jury also returned a verdict against former Bismarck police Sgt., Richard Peck, who the jury said subjected Falkenstein to "cruel and unusual punishment or treatment" and deprived him of his constitutional rights.

The victim's father, Leslie Falkenstein, was awarded \$27,000 from the city and \$25,000 in actual damages and \$6,000 in punitive damages from Peck. In his suit, the father said his son was moved into a cell known as "the hole" after he "foul mouthed" a police officer while under arrest on a drunken driving charge.

FROM THE PHOENIX (Arizona) GAZETTE: Most of the inmates in the overcrowded, explosive maximum security area of Arizona State Prison could be considered for placement in medium or minimum security areas.

That's what a committee of psychologists studying the problem says and the Department of Corrections agrees.

Now what?

It's one thing to find out the prisoners may not be classified properly, says Dr. David Beigen, who headed the committee. "But determining what can be done about it is another matter entirely."

The study began early this year after a suit was filed by the American Civil Liberties Union against the state concerning the crowded conditions of the prison, especially in the maximum security area. U.S. District Court Judge Carl Muecke ordered the state to come up with a detailed report on how the overcrowding could be relieved. Two local associations of psychologists formed a joint committee and offered their services to the court to look into the classification and the court took them up on their offer.

How To Win:

First, prisoners must become self-reliant in everything we do. We must become self-responsible and self-disciplined.

Secondly, we must communicate, coordinate, and unite with the outside community or we will only be committing suicide.

Thirdly, we must use every level of struggle that we know against the enemy, including his own laws.

Patience is mandatory. Organization, individually and collectively, is everything.

Unity inside and outside is the only way to win. To obtain that unity we must use our love and the truth. Tell no lies to, and play no games with, our friends.

Remember, we are all Brothers and Sisters behind these walls. Let the ignorance return to the ignorant, the only enemy of us all.

Do not become as the enemy is if you love yourself, and truely desire change.

FOLSOM PRISON

Meanwhile 130 men in the Adjustment Center (segregation) of the California state prison at Folsom went on a hunger strike July 26 as a further action in a protest that has been going on since July 11th. Key demands of the strike include better food, medical care, exercise time and facilities, and some protection from the hot summer sun. With outdoor temperatures of 115 degrees and more they have asked to be given straw hats or to have some structures built to provide shade. Prison officials have refused to negotiate until the prisoners decide to "behave." However, Attorney Michael Snedeker, retained by friends and families to. the prisoners, said "one of the key reasons the strike was called in the first place was that the Warden refused to talk with the men about grievances they had The state of the s presented."

On July 11th prisoners struck by collectively flooding their cells and refusing to stand for the daily "body counts." In response officials have put them on Restrictive Diet, Snedeker said. "This is where they take the leftover food in the kitchen, grind it up and make biscuits, and serve them with water."When the administration did this a hunger strike was called,"

Support for the strike has been building. Forty people demonstrated Saturday Jully 22nd outside Folsom prison, and more protests are planned.

Harvey Stable After Surgery

SHELTON - James R. Harvey, associate superintendent at Washington Correction Center who was wounded in a shooting incident early yesterday, was reported in serious but stable condition this morning.

Harvey, 44, was wounded by a shotgun blast in the face as he emerged from a Shelton apartment before dawn yesterday. He was rushed to St. Peter Hospital, Olympia, where he underwent several hours of surgery. He remained in the hospital's intensive care unit today.

Killed in the apparent shooting-suicide was Tony B. Nelson, 49, Shelton. According to authorities, Harvey was leaving the apartment of Nelson's estranged wife, Georgia, when the shooting began shortly after 5 a.m.

Nelson's wife recently filed in Mason County Supérior Court for dissolution of their marriage. Mrs. Nelson is employed as a corrections officer at WCC, located just northwest of Shelton. She works in an office adjacent to Harvey's office, The Olympian has learned.


Mason County Prosecuting Attorney Byron McClanahan said Harvey was walking towards the street outside the 900 Olympic Ave. apartment, when he was gunned down. The prison official was carrying a plastic laundry basket full of clothing when the shooting started. The wounded man fell some 10-15 feet from the apartment door.

McClanahan theorized Nelson waited behind a tall holly bush for Harvey to appear. The prosecutor said Nelson's car engine was cold, indicating the alleged assailant waited in the chilled, pre-dawn an for the other man.

A single shot struck Harvey in the face. He fell to the ground, the laundry strewn beside him. After Harvey went down, Nelson apparently turned the 20-gauge shotgun on himself and died instantly from a blast, McClanahan said, reconstructing the incident.

Harvey then got up and staggered to a neighboring house for help. He was still conscious when police arrived on the scene.

There were no eyewitnesses to the shooting, but several persons reported hearing two gunshots ring out. The incident occurred in the Angleside area southwest of downtown Shelton.

Instead, the cons banded together, stopped to witness shake-downs, rollowed the "Goon Squad" everywhere they went, and just generally remained peaceful and serene.

This terrified the guards. They locked themselves behind gates - and then secured the gates with chains and locks. Amazing. They have the guns. They have the State. They have all the weapons and tactics. But we won.

We did have one unfortunate occurance, however. Seems a Breezeway Bandit, specializing in ripping off the weak and old prisoners, had the misfortune of meeting Mr. B.P. Hammer - B.P. being short for Ball Peen. We understand that when Mr. Hammer got done talking to the guy, the misguided individual had taken an entirely different position. Prone. It is assumed that he, and others like him, are busy reaccessing their place in the social order.

One of the prisoners had some property confiscated from him on the grounds that the property (gun catalogues) should not be allowed inside institutions of this nature because they might be considered detrimental to security. GERMANY'S TERRIFYING WITCH HUNT

In cataloging the disasters that have beset civil liberties in the Federal Republic of Germany over the past several years, it is important to remember that the protection of individual rights has never been a priority of German governments. Invariably, when "a need for law and order" arises, civil liberties have disappeared.

The Berufsverbot. A small group of radicals, progeny of the student movement of the '60s, created a stir in the early '70s with a wave of bombings and kidnappings. The German government responded with Teutonic overkill.

In January of 1972, the Federal Chancellor and the heads of states signed the notorious anti-radical decree on the requisite loyalty of civil servants. (In the German context, "civil servants" includes not only all federal, state and local employees, but also all licensed professionals-all teachers, lawyers, doctors, nurses, etc. Its scope is overwhelming.) The decree, never voted on in Parliament, states in part: "Those appointed to the civil service are obliged to profess their loyalty to the constitution in a positive manner.... Membership of civil servants in parties or organizations that oppose the constitutional order, as well as support for such parties or organizutions, will normally lead to a conflict of loyalties. Where this may be the case . . . there must be an individual decision . . . to

determine whether the applicant acts at all times in accordance with the free, democratic constitutional order. If there is a reasonable doubt in this regard, that will, as a rule, justify the applicant's rejection." (Italics added.)

Under the decree, nearly two million present or prospective civil servants and licensees have been screened, and an estimated 4,000 denied government jobs or licenses. The fuzzy language, with the burden of proof on the applicant, remains the cornerstone of today's repression.

One nursing school graduate, for example, was denied a license to practice because her roommate at college had attended several anti-war rallies. A technician at a power company lost his job when he was seen with the sister of one of the imprisoned terrorists-although the sister had never been accused of anything,

The Berufsverbot has created a new class of social outcasts-"sympathizers." An anti-nuclear power bumpersticker is enough to qualify anyone for this label.

Attacks on Defense Attorneys, After the capture of many of the Red Army Faction (an urban guerrilla group founded by Andreas Baader and Ulrike Meinhof) in mid 1972, several leading criminal lawyers stepped in to defend them. Immediately, the government switched its attack to the main relatively undisturbed. lawyers. In 1974, the so-called Lex Bauder-

Meinhof was enacted. It allows a judge to remove a defense attorney from a case if the lawyer is "highly suspected" of engaging in conduct similar to that of his clients. Under this law, the lawyers chosen by Baader and Meinhof were removed from their cases just two weeks before the trial.

Another change in the laws allows "provisional disbarment" by the prosecution upon "suspicion" of misconduct. This law has affected most leading leftist lawyers in West Germany today, Also, a defense attorney is now prohibited from representing more than one person in the same or a related case. Thus, if 50 students were arrested at a demonstration or sit-in, they would need 50 lawyers.

The attacks on the lawyers culminated in a series of indictments of all the leading leftist lawyers in West Germany, charging that the lawyers had conspired with their clients "to assist them to continue to think of themselves" as urban guerrillas. Kurt Groenewold of Hamburg, was found guilty of this "thought" crime last July, fined \$40,000 and given a suspended two-year jail sentence.

The Real Threat. Neofascist gangs are openly training and recruiting throughout West Germany, and, though their numbers are small, their clearly illegal activities re-







ABOLISH Solitary Confinement

Following a 1975 law suit, solitary confinement was declared "cruel and unusual punishment" by the Federal Court of Canada, and yet few changes have actually taken place in Canadian prisons.

Prisoners continue to hold strikes, riots and take hostages in order to draw attention to the issue. Prisoners say, "...it's like you're buried alive in a concrete vault."

Prisoners in solitary have a high rate of suicide and self mutilation. many times that of the general prison population. Solitary causes them to suffer severe mental illness and extreme levels of hate and frustration.

As a prisoner of solitary confinement, you are thrown into a concrete box and left there for 23 1/2 hours a day with only 30 minutes of walking exercise. An administrative segregation cell consists of the following:


- *A bed made of one 3 inch foam on top of a cement slab.
- *One light bulb which is only turned off for 10 hours a day.
- *One combination toilet and sink with cold running water:
- *An 18 x 30 inch viewhole covered by bars and wire mesh with a view of the corridor.

At the B.C. Penitentiary, "Administrative Segregation" is the most destructive and cruel in practice. Administrative segregation is used against those prisoners whom the prison authorities label as possible threats to the "peace and good order of the institution." This means that they have either made escape attempts in the past or been involved in prison strikes and sit-ins over prisoners' rights issues.

A prisoner does not have to break any specific rule of the institution to be thrown into solitary, indefinitely. There's no due process, all it takes is the say so of a guard.


Solitary confinement is a wasteful and futile practice. Even under the present system, there are alternatives. (Administrative segregation could maintain tight security without strippping the prisoners of all their human rights.)

Citizens must take responsibility for conditions inside. The Canadian Prison System must be forced to recognize their own crime.

... While Federal Prison Industries continue to expand, total inmate employment at the Federal Correctional Institution for Women in Alderson, West Virginia will remain at the present level of thirty percent.

... The Federal Correctional. Institution at Pleasanton, California is scheduled to open its third inmate housing unit sometime this month. The new unit will house 117 women. While the prison system sees building such units as a solution to current overcrowding in the prisons, the flip side of such a tactic can also be seen as their means of justifying incarcerating more women. Bigger prisons are continually built and are also immediately filled to capacity, and within a short time are once again overcrowded.

... Prison industries at Pleasanton include: upholstered furniture, drapery production, and the manufacturing of weather-protective covers (Herculite) for the Navy.

... The Federal Prison Camp at Safford, Afizona remains to be the most isolated, prison camp in the Federal.system. houses 337 male offenders.

Lid Blows On Spanish Prisons

A showdown between the Spanish prison movement and its Francoist jailers is in the works following the naurder of a young anarchist militant while under "questioning" in Madrid's notorious carabanchel prison.

Agustin Rueda Sierra, 25, a member of the anarchosyndicalist CNT, was beaten to death by a guards' goon squad on March 13 after an escape tunnel was discovered in the prison. An autopsy attributed his death to "traumatic shock", but didn't specify the cause.

The authorities, moving quickly in an attempt to defuse the situation, immediately sacked the warden and two other senior officials. and suspended ten guards without pay. Charges were initiated against some of them, and various official investigations launched.

But a few days later, the first counter-blows were gunmen of the struck: shadowy Maoist guerilla group GRAPO shot and killed the Spanish Director-General of Prisons, Jesus Haddad; the CNT called a general strike in Sallents, Rueda's hometown, on the occasion of his funeral; and the newly minted Grupo Autonomo Agustin Rueda destroyed the entrance to Montpelier Prison in France with a powerful bomb.

Rueda's murder was the culmination of more than a year of heavy conflict in Spain's prisons-ever since the Suarez government declared an amnesty for political prisoners, but ignored demands to spring "common" criminals sentenced under Francoist laws.

Altogether, there have been about 40 major insurrections in Spanish prisons since July, 1970. For instance: prisoners at Modelo Prison in Barcelona fought pitched battles with police on three occasions, with many casualties on both sides; in Zaragoza, the prison was torched and home-made gas bombs thrown at police; in Carabanchel, where 75 per cent of the population is being held in lieu of bail or in preventative detention, the cell-blocks were seized and laid waste twice within six months.

As well, there have been numerous non-violent hunger strikes and work stoppages, and prisoners in a number of locations have slashed their veins as part of a coordinated campaign of pressure.

The prisoners' organization, COPEL, is anarchist-inspired, but it is no formal links to any outside organization. However, it does receive support from the CNT. which maintains the traditional anarchist position that all prisoners-political or common-are hostages of the State.

At the time of Rucda's murder, there were 23 known anarchist militants still in Spanish prisons, including 11 CNT members and 12 from autonomous groups. A police crackdown on anarchists in recent days has resulted in 250 arrests in Madrid alone, and another 170 in Barcelona on such pretexts as associating with international guerilla figure "Carlos."


Thanks again to all of you who have supported us both inside and out. We couldn't have done it without you. We love you all.
